

SUMMER TRAINING PARENT/PLAYER CONTRACT



Aloha & Welcome,

We wish to formally invite you to join **Tsunami Academy Summer Training**. We are very excited for this opportunity to improve your player's game! Our goal is to develop our players' fundamental & advanced skills, to prepare them for high school and begin the early development for their college careers.

2024 Baseball & Softball Training Description: Tsunami Academy educates players on both fundamentals and advanced training of the game. Each week, players will have an opportunity to experience different concepts through various programs with our staff, including professional MLB players & current college players for hands on instruction. Tsunami Academy offers state of the art technology and equipment for metrics that isn't offered anywhere else in the area! The advanced technology is amazing on its own, but paired up with our elite instructors to implement corrective movements and adjustments is what separates Tsunami Academy from the rest. At any level, mental toughness and a positive mindset is extremely important to a player's career. Understanding the importance of the mental game, Tsunami instructors will guide each player on techniques to control their emotions and channel their thoughts to reinforce a positive mindset.

Meals: Please provide your child with home lunch (No sharing/lunch delivery due to Covid-19). Tuition does NOT include lunch or travel to and from the camp.

Drop off/Pick up Information:

Drop off: ****Please drop off ONLY to help with the flow of traffic!**

An instructor will be in the front of the building to check each player in.

Session #1: Check in will be at 8:45am (9:00am-2:00pm).

For those wanting to walk in for drop offs, please find street parking along Old Middlefield Way. Please DO NOT park or drop off in the back of our building or the surrounding parking lots (Papa's & eggs & Ballet studio).

Pick up:

Session #1: Check out will be at 2:00pm (9:00am-2:00pm)

For pick up, parking is available alongside our building or on Old Middlefield Way. Please do not loiter inside the training area. We will have players exit through the back of the building after their session. For safety reasons, please walk to the back for pick up. We will release each player once they see you. If you're designating a driver such as grandparent or nanny, please notify us ahead of time. Please DO NOT loiter on the back turf where trainers are working with clients. We will designate a space for pick up in the back corner. Please look for designated signs.

Equipment: Each player must bring his/her own baseball equipment. Players should bring all the baseball necessities such as a glove, running shoes or turf shoes, and hat. There will be limited supplies of bats and gloves that can be provided upon request. Tsunami Academy requests that each player write his/her name and phone number on all equipment and items. Tsunami Academy is not responsible for any lost or stolen equipment.

***Nonrefundable Fee: Refund Policy/Cancellation:** A 100% Refund is only available if cancelled one month before camp start date. **A receipt will be sent to each participant once registration is complete.**

Should a player quit, withdraw or leave the team at any point, for any reason after accepting a position with Tsunami, no refund of any kind will be received by the player/parents. Should a player sustain an injury in other activities/sports outside of Tsunami training, no refund of any kind will be received by the player/parents. For the reasons stated above, Tsunami's operations are budgeted in advance in reliance of each player's acceptance of a position on the team. Therefore, all payments and fees will be nonrefundable.

*COVID-19: Should Tsunami have to go virtual (via Zoom) due to COVID-19 or limit the amount of players at a practice/lessons due to county imposed restrictions, Tsunami will comply with such restrictions and no refund will be issued.

Cancellation/Makeup Policy

During this uncertain time, there are situations beyond our control, which may or may not lead to the cancellation of practices, scrimmages, games and/or lessons. Tsunami's staff will do their best to makeup or reschedule cancelled events, where feasible, but it is not guaranteed. Situations including, but not limited to, air quality in California, changing time slots for field/facility use determined by the county, technical issues with lights at fields, field/facility closures due to COVID-19 at the discretion of the county and weather.

Media Rights and Reproduction Release

I hereby authorize and grant permission to Tsunami Academy, as well as their agents, representatives, and others working under their authority, to take and use my or my child's photographed, video recorded or live-streamed image, likeness, voice, and name for any and all purposes, including but not limited to, marketing, commercial, advertising or social media purposes, and in any and all forms of media, without further consideration. I understand and agree that I and my child have no rights to any benefits derived from the use of such image, likeness, voice or name.

Release of Liability and Assumption of Risk

Upon the signing of this contract, myself, my child(ren), my heirs, assigns and personal representatives hereby release from liability and waive the right to sue Tsunami and coaching staff, instructors, directors, officers, agents and volunteers, from and against any and all claims, injuries and/or damages, in which the player and/or parents may suffer during or as a result of the player's participation with Tsunami, including but not limited to travel to and from practices, games, practices, tournaments and related activities. I agree to indemnify Tsunami and coaching staff, instructors, directors, officers, agents and volunteers from and hold them harmless against any and all losses, liabilities, claims, damages, costs and expenses including legal fees and court costs of or in connection with the player's participation with Tsunami.
